#### "Maus" Ban

"Maus", written by Art Spiegleman in 1980, is a nonfiction graphic novel about the Holocaust. In this Pulitzer- Prize winning novel, the Nazi's are portrayed as cats and the Jews are mice which provides a less gruesome introduction to the Holocust while still educating youth on the tragedy. A Tennessee school board recently voted unanimously to remove "Maus" from its 8th grade curriculum. This decision was made on the objections to nudity and profanity in the text which immediately sparked backlash and was seen as a "red-flag" in the way we educate youth today. "It's been truly life-changing for so many students, so taking it away is incomprehensible," says Paul Regelbrugge, former teacher and now director of education for the Holocause Center for Humanity in Seattle.

## A Horrifying Start to Black History Month

The start of Black History Month is off to a shocking start with at least 14 Historically Black colleges universities (HBCU) reciving bomb threats on Monday and Tuesday. Many colleges and universities have postponed classes and locked down campuses as police and FBI try to find out where the threats were coming from. No explosives turned up and law enforcement deemed the threats non credible. These bomb threats are "of the highest priority for the Bureau and involves more than 20 FBI field offices across the country," stated the FBI. The New York Times reports that the FBI has identified six juveniles as persons of interest while BuzzFeed reports a neo-Nazi group may have been behind at least one of the threats. This has undoubtedly left students and faculty in fear and uneasy as they are awaiting more information to be revealed.

#### **COVID Update**
